JOB DUTIES:

- 1. Instruct assigned classes in the locations and at the times designated.
- 2. Plan programs of study that align to local and state curriculum guides and meet the individual needs, interests, and abilities of the students.
- 3. Create a classroom environment that is conducive to learning and appropriate to the maturity and interests of the students.
- 4. Prepare for classes assigned, and show written evidence of preparation in the form of lesson plans upon request of immediate supervisor.
- 5. Encourage students to take an active role in the learning process and encourage them to set and maintain high standards of personal behavior.
- 6. Guide the learning process toward the achievement of curriculum goals and --in harmony with the goals--establish clear objectives for all lessons, units, projects, etc. to communicate these objectives to students.
- 7. Strive to implement, by instruction and action, the district's philosophy of education and instructional goals and objectives.
- 8. Assess and communicate student progress or lack of progress to students and parents on a regular basis and provide progress reports as required.
- 9. Assess students' abilities as related to desired educational goals, objectives, and student outcomes and seek the assistance of district specialists as required.
- 10. Take all necessary and reasonable precautions to protect students, equipment, materials, and facilities.
- 11. Maintain accurate, complete, and correct records as required by law, district policy, and administrative regulation.
- 12. Assist administration in implementing all policies and rules governing student life and conduct, and, for the classroom, develop reasonable rules for classroom behavior and procedure, and maintain order in the classroom in a fair and just manner.
- 13. Be available to students and parents for education-related purposes outside the instructional day when required or requested to do so within reason

- 14. Plan and supervise purposeful assignments for aide(s) and volunteer(s) cooperatively with the principal and supervisors.
- 15. Exhibit effective human relations skills.
- 16. Demonstrate proficiency in written and oral communication.
- 17. Maintain professional growth and competence through professional development <u>as per Board</u> <u>Policy 5.5 Personnel – Professional Development</u>
- 18. Attend staff meetings, as required, and serve on staff committees as assigned.
- 19. Assist in daily duties, of which may be car duty, extra-curricular duties whenever students are involved in school activities.
- 20. Encourage students to set and maintain high standards of classroom behavior.
- 21. Adhere to school system rules, administrative procedures, local board policy, and state and federal rules and regulations.
- 22. Reviews with principal or designee, all plans, duties and schedules to be followed during the teaching day, teaches the outlined lesson, maintains as fully as possible the established routines and procedures of the school and classroom to which he/she is assigned.
- 23. Perform other duties as may be assigned.

Essential Duties

Job descriptions are designed and intended only to summarize the essential duties, responsibilities, qualifications, and requirements for clarifying the general nature and scope of a position's role as part of the overall organization.
